REPORT AND REVIEW OF COMPREHENSIVE ANNUAL FINANCIAL REPORT

CONSIDERATION AND ACTION ON A Finance Director Eric Burk introduced Joe Lightcap, Audit Partner from Baker Tilly Virchow Krause, LLP. Baker Tilly issued an unmodified opinion of the Village's financial statements for the year ended December 31, 2020.

Mr. Lightcap went through the report. He explained the audit includes one additional audit. The EB is a single audit triggered by Cares Act money received by the Village. Mr. Lightcap thanked Mr. Burk and the Finance team for their assistance in getting the information in a timely manner.

Mr. Lightcap discussed the income statement which shows the inflows and outflows of the major funds. The total fund balance went down about \$6.7 million due to the infrastructure replacement expenditure of \$8.2 million. The Enterprise funds increased about \$48,000 showing revenues and expenses were in line throughout the year. The police pension trust fund was up about \$7 million due to good investment returns.

Reporting and Insights look at the non-financial highlights, which satisfy various auditing standards. This shows the audit went very smoothly and lists future accounting standards.

The Report on Federal Awards is a new report due to Cares Act funding and stimulus money. This is a compliance report on the spending of the Federal funds. The Village had significant expenditures to offset the awards and is in a good spot going forward.
